The contributions received for the journal can be of the following types:

Articles and Research Papers (4000-9000 words)
Brief Communications (1000-1500 words)
Perspectives (1500-3000 words)
Book Reviews (1000-2500 words)
Hypotheses and Research Ideas (750-2500 words)
Research Abstracts (Upto 1000 Words)
Case Stories (Upto 5000 words)
Announcements (100-500 words)

Online Submission process

One may submit an article only after registering on the website.

The Peer Review Process

Each manuscript will be screened for its relevance and formatting compatibility with the broad guidelines of the journal. All manuscripts with evidences of plagiarism and excessive referencing will be rejected. All selected manuscripts will be forwarded to anonymous referees/reviewers (experts in the field covered in the manuscript) for review. The research paper shall be published subject to recommendation of at least two of the three referees. The referees may also suggest modifications/amendments if required. As a general principle, the reviewers will not ask the authors to change their political viewpoints. However, a reviewer may ask the authors to modify their arguments and theoretical underpinnings. The reviewers may also ask for more clarifications and inclusion of more explanations apart from suggestions on the format of the submissions. The review process may take up to maximum three months. The journal shall publish the article/papers of the authors completing the formalities in due time mentioned in the selection letter. The rejected papers shall not be returned.
